Mold Remediation Work Plans must be filed with NYC DEP no later than TWO (2) DAYS before the commencement of the mold remediation work. BROOKLYN, failed to file a mold remediation work plan based on their first inspection on 11-22-23 and subsequent re-inspection of the property and resumed remediation work on 11-22-23.

Infraction Code: Infraction Description

§ 24-154(b) Mold assess/abate/ remediation done by covered or unlicensed person - 1st offense

EQUIPMENT / APPARATUS IN VIOLATION: Failed to hire a Mold Remediation Licensed contractor.
